## Regulation

by the Landespolizeidirektion Salzburg (Salzburg Federal Police) of 13th October 2025

According to Article 49a of the security police law 1991, federal law gazette 1991/566, as hereafter amended will be decreed:

- **§ 1.** On the occasion of the football match **FC Red Bull Salzburg against Ferencvaros Budapest**, scheduled on **thursday**, **23**<sup>th</sup> **October 2025**, **at 06:45 pm**, which takes place in the stadium of the local community Wals-Siezenheim and can be classified as a major sporting event, the participation of violent individuals shall be taken into account. As experienced from previous and comparable events evidenced, a general danger exists for the physical health of various people and for the property to a great extent. Moreover it is to be found that there could be dangerous attacks according to austrian ban law or to Article 283 of the federal criminal law.
- § 2. The marked area at the attached map will be declared as safety area.
- § 3. The organs of the police are empowered to prohibit the entrance and to order off an individual of the safety area, if due to specific matters of facts, particularly by reason of preceding dangerous attacks against life, physical health, property, according to austrian ban law or to Article 283 of the federal criminal law in connection with comparable major sporting events it can be supposed that he may commit dangerous attacks by the use of violence in the area of application of the regulation.
- § 4. Anyone who enters the safety area in spite of the ban on entering, which has been declared against him, commits a regulatory offence according to Article 84 para 1 subparagraph 5 security police law and shall be punished with a fine of up to **EUR 1.000,--**, in the event of a repeatet offense fine of up to **EUR 4.600,--**; in case of irrevocability to a prison sentence up to **two weeks**.
- § 5. This regulation comes into effect on thursday, 23<sup>th</sup> October 2025, at 02:00 pm and expires on thursday, 23<sup>th</sup> October 2025, at 11:00 pm.

## Note on video surveillance according to Article 54 para 5 security police law:

On the occasion of this event, various people are expected to face dangerous attacks on life, health or property. The requirements of Article 54 para 5 security police law for the admissibility of the determination of personal data of present persons with picture and sound recording devices (mobile video surveillance) are thus present. If there is an identifiable need, the organs of the federal police will record personal data during the event or the fan movements to and from the stadium ("Red Bull Arena") to prevent dangerous attacks in the local area of action of the District Authority.
