The applicant sends the original completed forms to us via mail or courier.

The fingerprints are digitized with card scan technology and transmitted to the RCMP electronically.

The RCMP processes the fingerprints in 72* hours and sends the certified criminal record check to the applicant via regular mail.

RCMP-Accredited companies for electronic fingerprint submission

The RCMP has accredited a number of private companies to submit electronic fingerprints for the purposes of criminal record checks, which include vulnerable sector checks.

In addition to taking fingerprints electronically, several of these companies have the ability to receive fingerprints that have been taken on paper, convert them to electronic transactions, and submit them directly to the RCMP's Canadian Criminal Real Time Identification Services (CCRTIS) for processing. This service is also available to individuals whose fingerprints were taken outside of Canada. Submitting fingerprints electronically to CCRTIS substantially reduces the processing time for criminal records, including vulnerable sector checks.

Many of the accredited companies listed on this page are affiliated with other companies that also have the ability to submit fingerprints electronically to CCRTIS. The company websites list their affiliates and the services they offer.
